

OUT-OF-TOWN OR OVERNIGHT TRAVEL FIELD TRIP BOOKLET

This booklet includes Rockwood School District policies and regulations relevant to out-of-town or overnight field trips. Please carefully review the requirements with your child.

In order for your child to participate in the field trip, you will be required to complete two forms:

- 1) Out-of-Town or Overnight Travel Field Trip Permission to Participate, Release of Liability, and Indemnity Agreement, Form 5006.
- 2) Out-of-Town or Overnight Travel Field Trip Agreement and Student Information Form (either without a nurse attending on the trip <u>Form 5037</u>, or with a nurse attending on the trip <u>Form 5038</u>).

These forms incorporate the information from this booklet and require you to acknowledge that you have reviewed this booklet with your child, and that you agree to abide by the requirements. In addition, we have included the <u>Code of Conduct</u> for the teacher, sponsor or coach responsible for the field trip. We want to make you aware of their commitments concerning this trip.
